Changes to PRME UK & Ireland Annual Conference 2020

UKI Chapter 2020 Responsible Business and Management Writing Competition

The deadline for the 4th UK & Ireland PRME Regional Chapter responsible business and management writing competition passed on February 28th 2020. We are delighted to advise of a great take-up this year, receiving 82 applications in total from 19 Institutions, across undergraduate (52), postgraduate (17) and alternative media (13) categories. Judging is currently taking place and winners will be announced on the website, and via email, in early May, as long as our team of judges stay healthy and capacity permits.

UKI Chapter Seed Funding to Develop Innovative Pedagogic Approaches and Teaching Practices

In early 2020 the UK and Ireland Chapter of PRME launched a competition to support the development of innovative pedagogic approaches and teaching practices to support the implementation and integration of the SDGs in to the curriculum. Three awards are available up to the value of £750. **The deadline for this competition was extended to April 14**th **2020**, with winners being informed in the middle of May. UKI Chapter Research Paper Development Workshop Series 2021-2025

Do you have work in progress that would benefit from expert feedback from senior scholars? Are you looking to publish business and society research in top journals? PRME UK and Ireland, in conjunction with partner institutions (City University London, University of Bath, University College Dublin, University of Glasgow, University of Nottingham) is holding a series of five paper development workshops to help early and mid-career scholars develop their business and society work for publication. UN Global Compact (UNGC) 20th Anniversary Leader's Summit June 15-16th 2020

Similarly, the UNGC has decided to reimagine this year's 20th Anniversary Leaders Summit as a *virtual gathering* on June 15-16, 2020. We are living in uncertain times, but one thing remains true. There has never been a more important time for the global business community to come together in solidarity. This year's online experience will be bigger, bolder and more inclusive so that all of UNGC's stakeholders will be able to attend free of charge. The Global Compact hopes that you will join thousands of corporate sustainability leaders, CEOs, Heads of State, Government officials, and UN Principals in virtual plenary sessions, panel discussions, round tables, exhibitions and interactive networking sessions. This high-level programme will "chase the sun" to allow attendees and Global Compact Local Networks to participate in their own time zones and languages. New Head of PRME Global

In early April, Lise Kingo, CEO and Executive Director of the UN Global Compact announced the appointment of Ms. Mette Morsing as Programme Officer and Head of the Principles for Responsible Management Education (PRME) initiative with the UN Global Compact, effective 1 May 2020. Ms. Morsing will oversee the strategic development and implementation of the PRME initiative and its entire work programme, reporting directly to the CEO & Executive Director of the United Nations Global Compact. It was reported that Ms. Morsing brings extensive research and leadership knowledge on responsible management education and sustainable development from the classroom to the boardroom of management schools. Ms. Morsing is currently Mistra Chair of Sustainable Markets and Executive Director of Misum at Mistra Center for Sustainable Markets at Stockholm School of Economics, Sweden. She is also Professor of Corporate Social Responsibility at the Copenhagen Business School, Denmark. Ms. Morsing founded one of today's largest management scholar research centres in Europe and co-founded the Academy of Business in Society, Brussels. Ms. Morsing has been engaged in PRME since its establishment in 2007, including as PRME Nordic Chapter Chair.

I am sure you will join me in extending a very warm welcome to Ms. Morsing. Under her leadership and with your support, we look forward to an end of a period of uncertainty, and the beginning of an exciting new chapter for PRME to advance the responsible management education movement worldwide.

PRME Interim Management Council (IMC)

Pending Mette Morsing taking up her post on May 1st, <u>Professor Danica Purg</u> is serving as Acting Chair of the PRME Steering Committee, and overseeing the work of an Interim Management Council (IMC). The IMC is comprised of a small but dedicated group of individuals with strong leadership and PRME experience. Members of the IMC are Norman Aruda, David Cooperrider, Lisa Frohlich, Belinda Gibbons, Nikolay Ivanov, Nicola Kleyn, Mette Morsing, Sergey Myassoedov, and Andrew Main Wilson. The task of the IMC is twofold: to decide on the overall strategic framework for PRME in the future, and to appoint the new PRME Steering Committee that will be presented to the PRME Community at the online PRME Global Forum on June 17th- 18th 2020



Finally, in case it has slipped your attention, please note that effective January 1st 2020, the Secretariat for the UK & Ireland PRME Regional Chapter was moved to Glasgow Caledonian University (GCU).
